### VOLUNTEER WAIVER AND RELEASE

In consideration for being permitted by Valley Jewish Community Center (VJCC) to participate as a Volunteer, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may here after accrue to me, as a result of participation as a Volunteer. This release is intended to discharge in advance VJCC (including their officers, employees, volunteers, and agents) from any and all liability arising out of or connected in any way with my participation as a VJCC Volunteer, even though that liability may arise out of active or passive negligence or carelessness on the part of the persons or entity mentioned above. It is further agreed that this waiver, release, and assumption of risk is to be binding on my heirs, administrators, executors, and assigns, and that I shall indemnify and to hold the above persons or entity (including their officers, employees, volunteers, and agents) free and harmless from any loss, liability, damage, cost, or expense which may arise out of or is connected in any way with my participation as a VJCC Volunteer. Additionally, I fully understand that my participation as a VJCC Volunteer exposes me to risk of personal injury, death, communicable diseases, illnesses, viruses, and/or property damage. I hereby acknowledge that I am voluntarily participating as a VJCC Volunteer and agree to assume any such risk.

**VIRTUAL CLASS RELEASE:** I hereby warrant and agree, that the conditions of my environment are safe, free from obstructions, and are suitable for participation as a Volunteer. I further understand and agree that any material downloaded, viewed, or otherwise obtained through my participation as a Volunteer is done at my own risk and VJCC is not responsible for any loss, alteration, corruption or other damage to my personal property, including computers, networks and other property used as part of my participation.
